AGENDA - PART I

- 1. Call to Order-Chairman Bermingham Jr. called the meeting to order at 7:00 pm.
- 2. The Pledge of Allegiance was recited.
- 3. Roll Call-Present in addition to Chairman Bermingham Jr. were Supervisor Due, Supervisor Teel, Supervisor DeFranco, Township Manager Rick Fisher, Township Engineer Justin Coyle, and Township Solicitor Ron Karasek. Supervisor Pinter was present via phone conference.
- 4. Approve the Agenda-Supervisor Pinter stated he would like to add the PR Firm quote to the agenda. Manager Fisher stated he will discuss in his manager's report. MOTION by Supervisor Due, seconded by Supervisor Teel, to approve the agenda. Vote: 5-0.
- 5. Public Comment (5 minutes) Charlie Cole was thankful to hear the speed sign was up and running. Charlie commented on the difficulty of using the website. Manager Fisher stated he is in the process of updating the website. Charlie asked about the police survey. Chairman Bermingham Jr. stated he will provide an update in his report. - 1. Financial Reports-Bill List-Manager Fisher read the Bill List. **MOTION** by Supervisor Pinter, seconded by Supervisor DeFranco, to pay the bills in the amount of \$179,120.30. Vote: 5-0.
- 2. Monthly Reports
 - a. Engineer's Report-Engineer Coyle read his report. Engineer Coyle discussed his continuation with the Act 537 Plan Update, the Park Pavilion project, the Speed Awareness Devices, Lake Minsi Dam Repair project, the Township Paving and Chip Seal project, and review of a Grading Plan.
 - b. Solicitor's Report-Solicitor Karasek read his report. Solicitor Karasek discussed meetings attended, subdivision matters, zoning and other land use matters, outstanding developments on Litigation, and other misc. matters.
 - c. Manager's Report-Manager Fisher read his report. Manager Fisher discussed the County Blight Removal Task Force, meetings and training he has attended, and several other items he has worked on for the month. Manager Fisher stated he will be going on vacation and will not be attendance at the April 8th meeting and is requesting the March 25th WS meeting be changed to a voting meeting to cover any items he may have for consideration.

 MOTION by Supervisor Teel, seconded by Supervisor Due, to advertise the change from a WS meeting to a voting meeting for the March 25th meeting. Vote: 5-0.
 - d. Supervisor's Report-Supervisor Due had nothing to report. Supervisor Teel reported there is no business with the Planning Commission, the EMC

meeting went very good and will be planning another meeting in April. Supervisor DeFranco reported the road crew has been busy keeping up with the roads, due to the snow. Supervisor Pinter reported on the EDC meeting he attended. Chairman Bermingham Jr. reported the bus trip to the Philadelphia Flower was a good turn-out, the Mock Team Bedroom Event held at the Bangor Area School was very interesting and informative, the Fireman's Appreciation Dinner was a very nice event, the 4th of July celebration event is in the planning stages, and as far as the police survey, still awaiting calls from third-party marketing firms to conduct the survey. Chairman Bermingham Jr. stated he had the honor of meeting Steven Riker, a hiker that stopped off in Portland, who hiked from the Statue of Liberty on the Liberty Gap Trail.

- 1. Refuse Reductions, Application Refunds, Exonerations-MOTION by Supervisor Pinter, seconded by Supervisor Teel to approve the Refuse Reductions, Application Refunds, Exonerations. Vote: 5-0.
- 2. Advertise for Road Bids-Engineer Coyle gave a presentation of the Township Roads projects that need attention this year and also the long term plan. Engineer Coyle stated the estimated of cost of chip seal coating the recommended roads at approximately \$350,000. Engineer Coyle stated the estimated cost of paving the recommended roads at approximately \$250,000. There was a discussion on the budget for road projects. **MOTION** by Supervisor DeFranco, seconded by Supervisor Due, to advertise for Road Bids but to not include the overlay on Sunset Dr. Vote: 5-0.
- 3. Advertise for Lawn Maintenance-Manager Fisher stated he would like to advertise locally for Lawn Maintenance. **MOTION** by Supervisor Pinter, seconded by Supervisor DeFranco, to advertise locally for Lawn Maintenance. Vote: 5-0.
- 4. Pine Tree Lane Study-Manager Fisher discussed the traffic issue on Pine Tree Lane with tractor trailers. Manager Fisher stated he would like to have Township Engineer Coyle do a study on the road. **MOTION** by Chairman Bermingham Jr., seconded by Supervisor Teel, to have Engineer Coyle do a study on Pine Tree Lane. Vote: 5-0.
- 5. Park Grant-Manager Fisher discussed the Park Grant that was applied for in 2015, but was never completed. Manager Fisher stated a revised estimate of improvements, suggestions by the Park Committee, was prepared by Engineer Coyle. MOTION by Supervisor Due, seconded by Supervisor Teel, to approve the revised estimate for the Park Grant. Vote: 5-0.

- 6. Appointment to Open Space Advisory Board-Chairman Bermingham Jr. stated a letter was received from Jeff Manzi withdrawing his application. Janet Pearson recommended Laura Bocko. MOTION by Supervisor Due, seconded by Supervisor DeFranco, to appoint Laura Bocko to the OSAB. Vote: 5-0.
- 7. The Preserve at Upper Mount Bethel Township Deeds-Solicitor Karasek stated the Deed is done but did want to clarify the lots to be included to finalize the Deed. Solicitor Karasek stated he needs to know the permitted uses and non-permitted uses in order to complete the Ordinance.
- 8. OSAB Wetland Delineation Penn Bid-MOTION by Supervisor DeFranco, seconded by Supervisor Due, to approve to advertise the Wetland Delineation Penn Bid. Vote: 5-0.
- 9. Ackerman Farmland Preservation Request for Funding-There was a discussion regarding the area that is going to be preserved. Manager Fisher stated he will reach out to Marie Bentzoni at the Northampton County Farmland Preservation, to clarify the eligibility of the Robert A. Ackerman and Beverly A. Beahn farm. **MOTION** by Supervisor Teel, seconded by Supervisor Due, to table. Vote: 5-0.
- 10. Request to use Township Parking Lot for Wedding Guests-Manager Fisher discussed a letter he received from a township resident requesting to use the Township parking lot to park approximately 75-100 cars for a wedding being held at their home on Sunset Dr. There was a discussion regarding insurance coverage. Chairman Bermingham Jr. suggested checking on the insurance coverage at the park and to see if they would consider parking at the park.
- 11. Slate Belt Multi-Municipal Comprehensive Plan-Manager Fisher stated the Slate Belt Multi-Municipal Comprehensive will not be going through the COG, they are going to go directly through the 10 municipalities. They are looking for 3 representatives to represent the Township. Solicitor Karasek stated he is aware of the Agreement. Chairman Bermingham Jr. asked this be on the March 25th meeting. No action.
- 12. Blue Mtn. Antique Gas & Engine Association Signs-Manager Fisher stated that each year we waive the fee for the signs. **MOTION** by Supervisor Due, seconded by Supervisor Teel, to grant the waiver. Vote: 5-0.
- 13. Inter-Municipal Agreements-Softball-Manager Fisher stated that each year we complete the Agreements for Softball with Portland Borough, Roseto Borough, East Bangor Borough and Bangor Borough. Solicitor Karasek stated that the only formal agreement we have in the way of an Ordinance is with Lower Mount Bethel. **MOTION** by Supervisor Due, seconded by Supervisor Teel, to sign the agreements. Vote: 5-0.

14. New Truck to replace #17-Manager Fisher stated that he has only one truck at this time. Manager Fisher also stated he is working a five year plan of replacing trucks. Chairman Bermingham Jr. asked for this to be on the March 25th meeting. No action.

Manager Fisher stated that water and sewer are not part of the program. Jim Potter asked about the fire study. Supervisor DeFranco asked Solicitor Karasek if the Township could appoint a Fire Commissioner to oversee the fire companies. Solicitor Karasek stated that the fire companies are independent companies, separate from the Township. Solicitor Karasek stated that a Board Liaison could be appointed, establish a fire committee, or hire a consultant. Lindsey Manzi suggested putting the Nixle program in the next newsletter.

Vote: 5-0.
