Discussion on 2019 Project Costs-Township Manager Fisher discussed with the Board the 2019 Project Costs. Manager Fisher went over each project cost, where we cut the cost and how we can balance the budget with no tax increase. Projects included are police service, ambulance service, traffic light, Act 537 Plan, water study, northern tier trail, guiderail river rd., eastern buildings, a digital file scanning project, which will assist with administrative duties, a network upgrade, SlateFord bridge, and LERTA expansion. Total Costs: \$738,000. Manager Fisher and the Board of Supervisors were able to cut the costs down to \$404,000.

Manager Fisher stated that he wanted to provide the Board with an update regarding the Police. Manager Fisher stated he received a call from Principal Financial, Police Pension Fund, regarding one of the beneficiaries of a deceased police officer. Manager Fisher stated he visited the beneficiary and provided her with a death notification form to be completed. The beneficiary stated that she might not accept the pension, which could take her out of the loop and that she will provide the form to her son, an attorney, to review. She also stated that she has been in contact with one other police officer. Manager Fisher stated that he felt it was important for the Board to be aware of this current occurrence and that before they move forward with the police project, the Board should consider seeking legal assistance.
