LAND DEVELOPMENT

a. Cloverleaf Saddle Club New Equestrian Facility Preliminary/Final LD Plan-Matt Evans, Engineer for Keystone Consulting Engineers, discussed the L/D Plan. Matt stated that they are not here tonight looking for any official action to be taken, they are here tonight to discuss Engineer Coyle's review letter. A zoning variance was granted by the ZHB to allow the proposed use of the facility. The plan is to propose an indoor equestrian arena, an outdoor warming-up/riding area, grass parking areas, on-lot well and septic. There was a discussion on Engineer Coyle's zoning comments 1) second access point, 2) slope percentages, 3) lighting. Engineer Coyle recommends reaching out to the Zoning Officer. There was a discussion on SALDO Waiver requests, which will need to be distributed to any neighboring property owners. There was a discussion on landscaping. **MOTION** by Commissioner Teel to table, seconded by Commissioner Crane. Vote: 4-0.

They would like to connect to Portland for sewer, they have water. There was a discussion on SALDO Waiver Requests. Rich Valone spoke briefly about the plan. They will be submitting a planning module. They already have a utility easement from Air Liquide up Demi Rd. They will provide a copy of the easement. Engineer recommends getting a will serve letter from Portland, send waiver requests letters out to adjoining property owners and add any items from the ZHB.
