### UPPER MOUNT BETHEL TOWNSHIP PLANNING COMMISSION MEETING MINUTES WEDNESDAY, SEPTEMBER 18, 2024 – 7:00 PM

#### I.

Commissioner Teel called the meeting to order at 7:00 pm.

The Pledge of Allegiance was recited.

Present were Commissioner Teel, Commissioner Sarisky, Commissioner Crane, Commissioner Potter, Commissioner Klein, Township Solicitor Karasek and Recording Secretary Cindy Beck. Dan Wilusz/Carroll Engineering, attended in Engineer Coyle's absence.

## **Public Comment**

Charles Cole, Riverton Rd., commented on the RPL Drip Irrigation, and is hoping the discussion on this includes the pros and cons.

Michael Onufrak, Summerfield Dr., commented on the RPL Drip Irrigation and is hoping that the Planning Commission sends a non-favorable recommendation to the ZHB. This is an environmental disaster, with a major impact on health, and home values.

Mark Mezger, Scenic Ct., commented on RPL's application for special exception submitted in December of 2022. Mark circulated a petition on the objection of the Wastewater Treatment/Drip Irrigation and received 750 signatures. Mark expressed his concerns about the quality of the water aquifer.

## **APPROVE THE MINUTES**

a. July 17, 2024, Meeting Minutes-**MOTION** by Commissioner Klein to approve the July 17, 2024, meeting minutes, seconded by Commissioner Sarisky. Vote: 4-0-1. Commissioner Crane abstained.

RPL Drip Irrigation Field Recommendation for Zoning Hearing Board-Rob Lewis stated that he is here this evening to discuss the request for a recommendation from the Planning Commission on the Drip Irrigation Field Special Exception for the ZHB, which is part of the application process. A planning module has been submitted to DEP, as well as reviewed by the Township Engineer. The Commissioners asked a series of questions in which Rob answered. Solicitor Karasek asked for the three (3) experts that testified. Rob responded: Joe Valentine-Soil Scientist, Fred Ebert-Engineer, and Jeff Clark-Geologist. Commissioner Potter had no comment, he has not been following the hearing and would like to make a motion to send no recommendations. Solicitor Karasek stated that the ZHB is looking for Planning Commission recommendation. Commissioner Klein would of liked to have seen another option for a drip irrigation field. **MOTION** by Commissioner Potter to send no recommendation to the ZHB, seconded by Commissioner Teel. Commissioner Klein commented that he thinks there could be another way. Commissioner Sarisky commented that one solution would be to hook up to Portland. Rob said they were advised that Portland does not have the capacity. Commissioner Teel called for a vote. Vote: 5-0.

- b. Ott/Race Minor Subdivision-Brian Pysher, Stateline Engineering discussed the plan. Brian stated that they went before the ZHB last month for a variance from the minimum lot size increase due to the presence of steep slopes, along the road where there is an existing stone row and bank. The variance was granted. Solicitor Karasek asked Brian if he would like the PC to act on the waiver requests, three of which have been already granted, SALDO Section 302.4.1.3, 302.4.2.6 and 400.4.5. SALDO Section 302.4.7.8 and 400.2.8 (roadway dedication) need PC recommendation for approval. **MOTION** by Commissioner Sarisky to recommend granting waivers to the BOS, seconded by Commissioner Klein. Vote: 5-0. Solicitor Karasek went over the Agreement for Conditional Plan Approval form, compliance with conditions set forth in Engineer Coyle's review letter of July 16, 2024. The agreement has been signed by the applicant's representative, Brian Pysher. **MOTION** by Commissioner Klein to recommend Conditional Preliminary/Final Plan Approval, seconded by Commissioner Sarisky. Vote: 5-0.

# LAND DEVELOPMENT

Well Ordinance-Dave Friedman, Well Committee Liaison, discussed the amendment to the well ordinance. The Township proposes to modify provisions of its current regulations to create a stand-alone ordinance. Applicants proposing to drill a well within the Township, including those whose projected water use is in excess of 2000 gallons per day. There will be a new well-ordinance officer, Scott Policelli. A DCNR water well competition report shall be provided. Dave went over the proposed fee schedule for each class. Commissioner Potter stated that out of 2700 homes in the township, only 180 wells are recorded. Charlie Cole stated that maybe hiring an intern to go out and survey properties to get them in the database.
