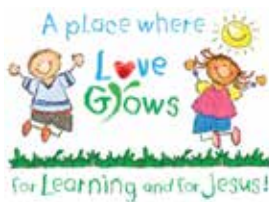

What Type of Permit(s) Do I need?

The following information is a brief overview. If you are uncertain, always contact the Building Code Official (BCO) and the Zoning Officer to confirm permitting requirements prior to proceeding with your project.

The following guidelines apply to single-family dwellings, two-family dwellings, townhouses and structures that are considered to be accessory to these types of residential structures. Any other uses or proposed construction would be considered “COMMERCIAL” and must comply with the requirements for commercial buildings. Please contact the Building Code Official (BCO) and Zoning Officer for more information on how to determine the requirements for any proposed commercial construction.

Required Residential Permits

ZP: Zoning Permit

BP: Building Permit

1. Decks

- a. 30” or less at the highest point of the deck walking surface measured from the adjacent grade, not located at the main exit door and without a roof: **ZP**
- b. Over 30” at the highest point adjacent of the deck walking surface measured from the grade or if the deck is located at the main exit door: **ZP** and **BP**
- c. Replacing an existing deck requires permits as specified in a. and b.

2. Porches or Decks with a roof

- a. **ZP** regardless of the height of the walking surface

3. Enclosing a Porch or Patio

- a. **ZP** and **BP**

4. Sheds or Garages

Under 1,000 square feet of total floor area and accessory to a single family dwelling: **ZP**

- a. 1,000 square feet of total floor area or larger: **ZP** and **BP**

5. Fences

Fences 3 feet to 6 feet high: **ZP**

Fences higher than 6 feet: **ZP** and **BP**

6. Retaining Walls

- a. Up to and including 4 feet high measured from the adjacent grade: **ZP**
- a. Retaining walls higher than 4’ at any point measured from the adjacent grade: **ZP** and **BP**

7. Swimming Pools

All swimming pools that are capable of holding 24” or more of water: **ZP** and **BP**

Barriers (e.g. fence) required by the International Residential Code must be provided.

8. Hot tub or Spa

- a. Indoor: **ZP**
- b. Outdoor: **ZP**

9. Additions

- a. Any size: **ZP** and **BP**
- b. Garage attached to the house: **ZP** and **BP**
- c. Carport attached to the house: **ZP** and **BP**

10. Alterations

- a. Alterations that involve structural changes: **BP**

A zoning permit may be required, depending upon the scope of work.

Please do not proceed with a project of this type without first contacting the code official for guidance.

11. Changes to an Existing Mean of Egress

- a. Removal or change: **BP**

A zoning permit may be required depending upon the scope of work.

- a. Ramp: **ZP** and **BP**
- c. Exit door: **BP**
- d. Stairs: **ZP** and **BP**
- e. Handrails: **BP**
- f. Guard system: **BP**

12. New Homes

- a. Traditional: **ZP** and **BP**
- b. Manufactured (new or used): **ZP** and **BP**
- c. Modular (new or used): **ZP** and **BP**

13. Demolition

- a. Residential Structure: **BP**
- b. Commercial Structure: **BP**

14. The Project Involves:

- a. Removal, replacement, re-enforcement or cutting of any structural beam or header or any load-bearing support wall: **BP**
- b. Work or service to the electrical service to the dwelling that will require an inspection by the power company and UCC inspection. Commercial Electrical Service requires **BP** and Inspection.
- c. Cutting away of any wall, partition, or portion thereof: **BP**
- d. Addition to, alteration of, replacement or relocation of any water supply, sewer, drainage, gas, soil, waste, vent or similar piping: **BP**
- e. Addition to, alteration of, replacement or relocation of any electrical wiring: **BP**

- f. Addition to, alteration of, replacement or relocation of any mechanical Equipment: **BP**
- 15.** Any portion of a dwelling or residential accessory structure that will be used for commercial purposes (open to employees or the public) Examples include but are not limited to:
- Professional offices
 - Business offices
 - Notaries
 - Beauty Shops, nail salons, barber shops
 - Car or equipment repair

FEES: A \$135.00 application fee is due with all residential Zoning Permit applications. Any additional zoning fees are due upon issuance of the permit. The building permit fees are separate from the zoning fees and are due upon issuance of the permit. Checks should be made Payable to Upper Mount Bethel.

Any construction that requires a building permit also requires a grading plan review by the Township Engineer.

Please keep in mind that doing work regulated by the Uniform Construction Code (UCC) without a permit will result in an enforcement action being taken against you by the municipality,



and upon conviction, you may be subject to fines and penalties up to and including \$1,000 per day of each violation.

Also, occupying any structure without a Certificate of Occupancy issued by the BCO is a serious violation and will also result in enforcement action. Please do not occupy or begin using any structure without a Certificate of Occupancy.

If you fail to obtain permits, inspections and certificates of occupancy, it is very likely that you will have serious difficulties when you eventually try to sell your house or property, as all structures built since April 9, 2004 must have a legal certificate of occupancy.

EDC 2024 News

Growing Our Business Community Together

Do you have a favorite business that you patronize on a regular basis in our township? How about a business where you have to travel outside of our area because we don't yet offer that product or service? Our township Economic and Development Committee has been hard at work partnering with township business owners to address our ever-changing landscape, identifying potential business opportunities where we have existing gaps, and determining the best ways possible to tell not just our residents, but also tourists coming to our area, about the many unique businesses and experiences that our township has to offer.

In 2023, the EDC sponsored several meet and greet sessions with local business owners at Tuscarora Inn to garner feedback to some ideas from the EDC about the local business landscape. As part of the discussion, the business owners were in agreement that for the area to really shine, it would be imperative to create an identity for our business community. We have restaurants, butcher shops, wineries, breweries, garden and feed centers, gas stations, fruit and vegetable growers, Christmas tree farms... the list goes on and on. But, we aren't an urban area

with a downtown built around Main Street. So, what should we be known as now and in the future and what business(es) - products and services - would make a great fit for our growing community? The EDC helps to connect those dots while developing tools and resources like the upcoming local business directory (www.umbt.gov/businessdirectory) and glossy marketing brochures for placement in area rest stops and other businesses to bring people (and revenue) into our township.

As the EDC looks ahead to the Spring and Summer of 2024, there are some immediate challenges on the horizon. With the upcoming development at the RPL site along River Road, we have heard from many residents about the need for transparency and open communication with the developers and UMBT. We are currently working with the developers to provide a monthly update on current events at their River Road site, along with open Q & A sessions with residents to address their concerns regarding the RPL project in UMBT. Please keep an eye out for future announcements on this topic.

The EDC will continue working with area businesses to further our goal of branding our community, driving economic growth to help offset the tax burden placed on residents and filling gaps in the products and services needed within our community. If you have an idea that you think would be of benefit to our community post it to our facebook page (UMBT Economic Development Committee) or better yet, come to a meeting! The committee meets the 4th Thursday of every month at the township building and would love to hear about your idea.

The UMBT Economic and Development Committee is composed of township residents including business owners volunteering their time, talents and collective expertise to further the connection between existing businesses and our community. In addition, the committee partners with local, city and state community development organizations and officials to get the pulse of

UMBT Environmental Advisory Council (EAC)

UMBT Environmental Advisory Council (EAC) reactivated in 2024

Among the many actions of the 2024 Board of Supervisor to bring timely information to residents was to reactivate the Township EAC. The original EAC was approved by ordinance in 2000, following Pennsylvania EAC regulations and guidelines. The past Board quietly unseated the Council during 2021-2023.

The EAC handbook describes community EACs as appointed by their local government to advise on protection, conservation, management, and use of their natural resources. EACs have no power and work as a liaison between the community and its officials.

The UMBT EAC will meet on the first Wednesday of the month at 7 PM at the Township Building. Public attendance is welcome to discuss current topics and bring unknown issues to residents. EAC plans to post our agenda and minutes as a page with other committees on the Township website.

Members were appointed with the approved reinstatement on March 11, 2024 bringing a wide range of experiences from farming, business and education, whether gained academically or through hands on life learning experiences.

Judith Henckel, chairperson. Founding EAC member and historian, an environmental advocate with Bachelor and Master Degrees in Science, specializing in environmental education and wildlife research focusing on birds of prey (raptors).

Courtney Gilmour, co-chairperson. Her background as a foster parent, community organizer and history of volunteerism with a love of outdoors brings experience and an innovative perspective to the municipality's planning challenge of balancing economic revitalization with environmental preservation.

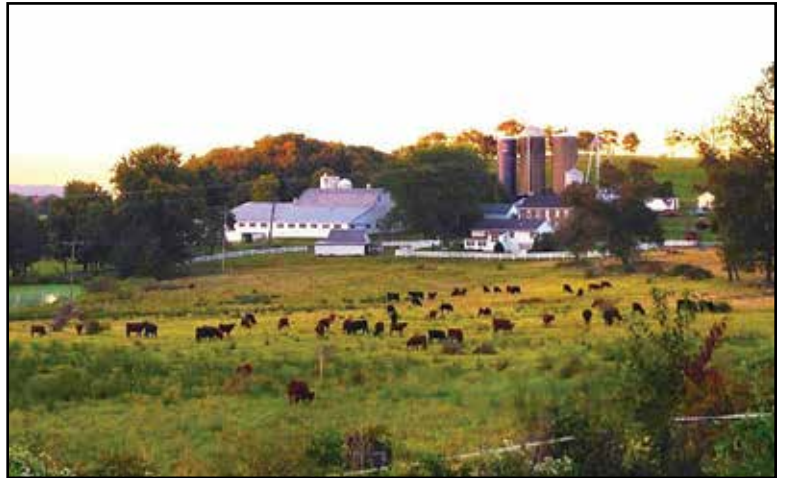
Alexandra Dutt, secretary. A combination of Bachelor of Science in Agricultural Science and a Master of Education in Agriculture and Extension Education Degrees; local government experience in law and ordinances; and employment with a renewable energy company brings agriculture and environmental education together with business and government experiences.



Allison Heinsohn. A member of several local watershed organizations and land trust, volunteers on stream watch projects, like riparian buffer and invasive species removal. Her citizen science expertise as a Penn State Master Watershed Steward can help guide the Township toward a more diverse tax base while maintaining our rural character.

Dohl DiFebo. A fifth generation farm owner managing over 350 acres on the first preserved farm in our Township, which was awarded the first National Leopold Conservation Award in farming, east of the Mississippi. Another community endeavor is the organic cattle farming demonstration on the Ott Environmental Learning Center at Bangor Area School District. Both, along with computer programming, are a voice bringing organic agriculture, open space and environment together for future decisions the Township faces.

Upper Mount Bethel Township FURR (Feline Urban Rescue and Rehab, Inc.)

As most know, the unfortunate issue of homeless feral cats touches most communities, including Upper Mount Bethel. How can we help in solving this difficult problem? The organization, FURR has been working to ease this problem in our area and has become an important resource. You may be asking, "What is FURR?"

Feline Urban Rescue and Rehab, Inc (FURR) was founded in 2003 and is licensed to do business in Pennsylvania. FURR has no shelter building and no paid staff. We are a volunteer, foster based rescue for cats. FURR touches the lives of approximately 1,000 cats each year through rescue, foster and adoption (averaging 600 cats each year) and through Trap Neuter, Vaccination and Return (TNVR) of community/feral cats (averaging close to 400 cats each year).

FURR also offers a Seniors for Seniors Program that places senior cats with senior citizens. In this program, FURR continues to pay for all medical expenses, and the senior citizen provides a home, food, litter and love. Removing financial barriers can create a win-win situation: senior citizens receive the companionship of a senior cat, and the senior cat gets a home. In the event that a senior citizen can no longer provide care for the cat, the cat returns to FURR. We also operate a Barn Home Program where community/feral cats that are in imminent danger can be relocated and acclimated to a safe farm.

FURR recognizes the need for affordable and accessible spay/neuter services for cats and the need to engage the community in working to end the overpopulation crisis of cats. On February 20, 2024, FURR opened **the only low cost spay/neuter clinic in Northampton County called FURR Fix**, located in Bangor, PA. Community members can schedule appointments on our website www.felineurbanrescueandrehab.org for both pet cats and community/feral cats (TNR). FURR is able to lend traps and teach community members how to humanely trap community/feral cats. You must schedule an appointment before trapping as the clinic is open on average four days per month, providing over 100 spay/neuters monthly.



FURR has contracted with the Borough of Pen Argyl who will pay for 10 community/feral (TNR) cats. Vouchers can be obtained at the Borough Office. FURR has also partnered with the Monroe Animal League for community/feral TNR. Contact the Monroe Animal League to apply for vouchers. Have questions? Give us a call at (610) 881-7600. You can also visit our Facebook page, Friends of Feline Urban Rescue and Rehab. We are excited to continue to work with the community! Want to help? Here are some things you can do:

DONATE! We receive no governmental funding and few grants. We depend on our supporters and fundraising to help as many cats as possible.

FOSTER! Fosters are needed for both kittens and adult cats

ADOPT! All cats available for adoption are on our website

VOLUNTEER! We have opportunities to match what you want to do.

Thunder and lightning storms happen all the time. Know what to do to keep you and your family safe when storms strike!

Safety Tips

Outdoor Safety

- ||| If you can hear thunder, you are within striking distance of lightning. Look for shelter inside a home, large building, or a hard-topped vehicle right away.
- ||| Do not go under trees for shelter. There is no place outside that is safe during a thunderstorm.
- ||| Wait at least 30 minutes after hearing the last clap of thunder before leaving your shelter.
- ||| Stay away from windows and doors. Stay off porches.
- ||| There is no safe place outside. Places with only a roof on sports fields, golf courses, and picnic areas are not safe during a lightning storm. Small sheds should not be used.
- ||| If a person is struck by lightning, call 9-1-1. Get medical help right away.

Indoor Safety

Turn off computers. Stay off corded phones, computers, and other things that put you in direct contact with electricity or plumbing. You can use a cell or cordless phone.

Do not wash your hands, bathe, shower, do laundry, or wash dishes.

Fireworks Safety

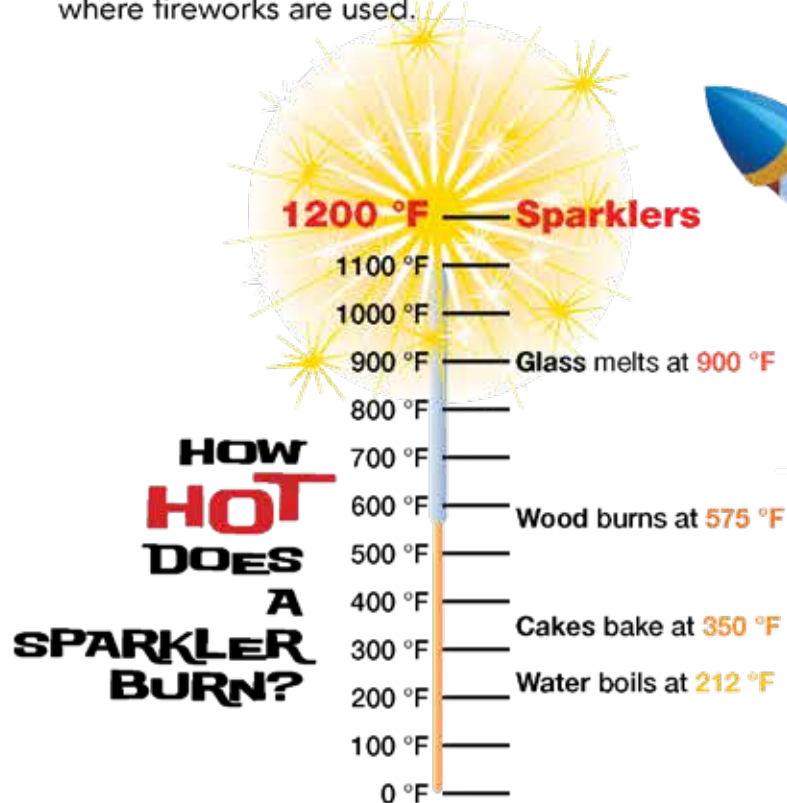

BE CAREFUL!

- »»» Be safe. If you want to see fireworks, go to a public show put on by experts.
- »»» Do not use consumer fireworks.
- »»» Keep a close eye on children at events where fireworks are used.

CONSUMER FIREWORKS

NFPA is opposed to consumer use of fireworks. This includes sparklers and firecrackers. Even sparklers burn hot enough to cause third-degree burns.



FACTS

- ❗ Fireworks cause an average of almost 18,500 reported fires per year.
- ❗ Sparklers account for more than one-quarter of emergency room fireworks injuries.

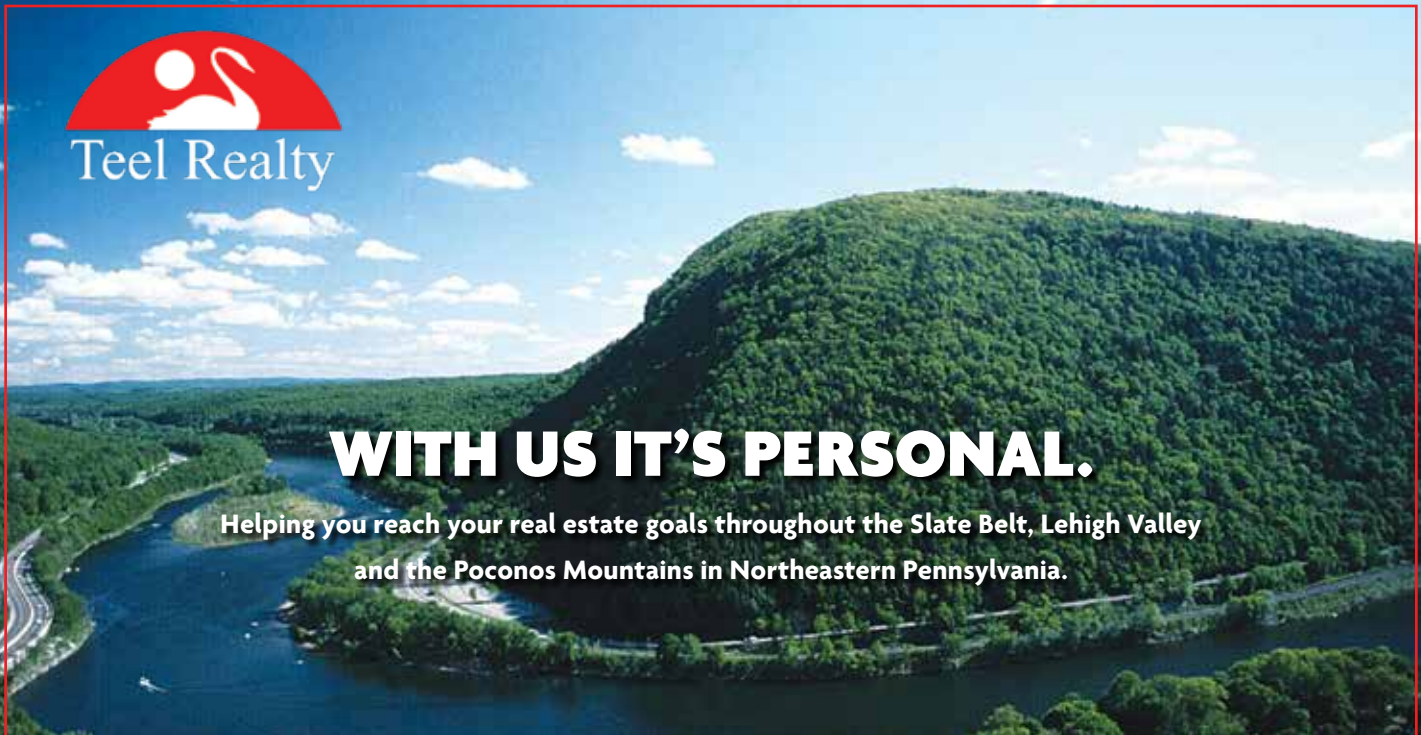
